


Safety Warnings



Operation Instructions

Setting Up the 6-Port Tower Charger

- Plug the AC Power Cord into the AC Power Input of the 6-Port Tower Charger.
- Plug the opposite end of the
 AC Power Cord into a Wall Outlet.
 The LED Power Indicator Light
 will illuminate.
- Choose to stand the 6-Port Tower
 Charger vertically or lay it horizontally.
 - Use the Tower Stand for a vertical set up.
 - Remove/do not use the Tower Stand for a horizontal setup.





NOTE: There is a protective film on the non-skid pad located on the bottom of the Tower Stand that should be removed.

Operation Instructions cont'd

Charging with the Type-C Port

- Plug the Type-C connector of a charging cable into the Type-C Port (Output).
- Plug the other end of the Type-C charging cable into a device.




NOTE: Not all devices and laptops are compatible with Type-C. Please refer to the devices user manual for instructions on the proper way to charge the device.

Charging with the USB-A Quick Charge Port


- Plug the USB connector of a charging cable into the USB-A Quick Charge Port (Output).
- Plug the other end of the charging cable into a device.



Operation Instructions cont'd

Charging with the USB-A Port

- Plug the USB connector of a charging cable into one of the USB-A Ports (Output).
- 2. Plug the other end of the charging cable into a device.
- Repeat steps 1-2 to add additional devices to the 6-Port Tower Charger.



NOTE: Charging times may vary by device. The 6-Port Tower Charger has a max total output of 53W. Exceeding these limits may cause the 6-Port Tower Charger to go into overdraw protection. Refer to page 10 for additional information.

Overdraw Protection

Charging times may vary by device. The 6-Port Tower Charger has a max total output of 53W. Exceeding this limit may cause the 6-Port Tower Charger to go into overdraw protection.

When multiple devices are connected, the 6-Port Tower Charger may, at times, reach its maximum charge capacity causing the connected devices to charge at a slower rate. If this occurs, remove a connected device to resume optimal charge.
